**REVIEW OF WILLARD ELLIOTT BROWN'S JACKET AT COMBINED RECORDS -
NORTH CAROLINA DEPARTMENT OF CORRECTION:**

On December 17, 2003, Assistant Special Agent in Charge (ASAC) M. S. Williams and Winston-Salem Police Department Detective M. C. Rowe reviewed the North Carolina Department of Correction jacket of Willard Elliott Brown, DOC #0052172, at the Combined Records Section of the Department of Correction in Raleigh, North Carolina.

The review was to determine if Willard Brown was in prison on August 10, 1984.

Willard Brown was an active inmate in the North Carolina Department of Correction on the following dates:

March 31, 1977 - February 19, 1981
June 10, 1982 - June 14, 1984
May 1, 1986 - September 30, 1988
September 16, 1992 - May 24, 1993
October 1, 1997 - January 2, 1998
November 8, 2002 - March 21, 2003

The following information was obtained from the Forsyth County Clerk of Court's Office and Detective R. A. Spillman of the Winston-Salem Police Department.

Subject was charged with 2 counts of Breaking, Entering and Larceny. The first incident occurred on 1-20-85. Subject Willard Brown did break and enter Bob's place, a game room, located at 1521 E. 14th Street in Winston-Salem. The subject did steal \$100.00 in currency, \$150.00 worth of assorted beer in cans and in bottles, \$59.85 worth in assorted cigarettes and a Kerosene Heater, having a total value of \$449.85. The break-in occurred between midnight and 8:00 a.m. on the 20th. Entry was through the front door, which had the glass broken out and the door unlocked. The Juke Box inside the gameroom had been pried open and the money taken from it. The beer cooler had been left open and 15 cases of beer were missing. There were no investigative leads at the time. Barbara Campbell who worked at the game room heard that Anthony Brown and his brother were responsible for the break-in. The subject, Willard Brown and his brother Anthony, lived in the residence right next to the game room.

On 3-5-85, Detective Spillman investigated Anthony Brown and he admitted to the break-in along with his brother, Willard.

The other break-in occurred on 3-3-85 at Bernard's Superette, located at 1535 E. 14th Street in Winston-Salem. Taken in the break-in were a Magnavox black and white TV, Kerosene Heater, assorted beer, wine, cigarettes and grocery items. The total value of the items taken was \$1,166.25. The incident was similar to the one of January 20th. This store is located in the same block where this subject, Willard Brown lived and it was broken into during the nighttime hours. According to Det. Spillman, none of the items taken were recovered.

After sometime, the subject was arrested and charged with the two break-ins and larcenies. He plead guilty on 4-28-86 and upon a plea of guilty, the subject was sentenced to 8 yrs. to be served in the State Department of Corrections.

This Officer spoke with Det. Spillman of the Winston-Salem Police Department who investigated these break-ins. He advised that the subject was not cooperative during their investigation. He stated that when he was arrested, he was hiding in the rafters in the attic of this residence. He did not give a statement. The Detective stated also that the subject would not work and that he committed these crimes to support a drug habit. Det. Spillman is opposed to parole for this subject based on his prior record and his actions in the course of their investigation.

PPO's Recommendation and Comments:

No more than a 90 day parole is recommended in this case.

Willard functions with normal intelligence and achieves at the second grade level. He was placed in Special Education Curriculum in school and was sent to training school on five separate occasions beginning at the age of ten. He was in the tenth grade when sent to prison in 1977 at the age of sixteen. Willard has no real vocational skills and an unstable employment history. Contends he was unemployed during most of 1985 while attempting to avoid arrest on current offenses.

PHYSICAL & MENTAL HEALTH - Welsh Code: FL'K/28*74"1630'59-

Willard voices no medical complaints. An initial physical examination revealed no clinical condition which would preclude a normal work assignment. No reported history of mental health intervention. Denies any history of suicide attempts and divulges no current suicide ideations. Willard was referred to the staff psychologist based on current testing results which indicated "depression".

SUBSTANCE ABUSE HISTORY -

Subject reports a lifestyle which includes frequent use of alcohol and denies any use of other drugs.

FAMILY, FRIENDS & COMMUNITY RELATIONSHIPS -

Willard was the tenth born of fourteen siblings reared in an impoverished socio-economic childhood environment in urban Winston-Salem, North Carolina. He was sent to training school for criminal type offenses and reports that two older brothers and a sister have all served felony prison terms. He was reared in a high delinquency low-income environment and states a younger brother was involved in his current crime. Willard has never been married but claims four illegitimate children dependents (he does not have court ordered child support for these siblings).

MAJOR ISSUES REQUIRING SPECIAL ATTENTION:

Participation in an ABE program in addition to vocational training programs is strongly recommended.

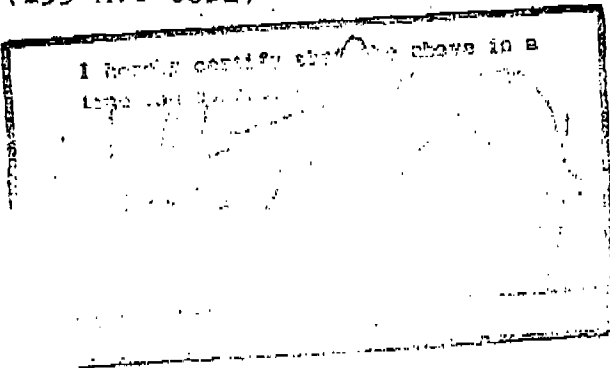
